

GUEST COUPON can be used by the tax-exempt person themselves.

Here's what you'll need:

- Device (e.g., smartphone)
- Email address
- Passport (No copies. No photography.)

To confirm your tax-exempt status, please present your passport with a landing permit sticker indicating one of the following statuses:

- Temporary Visitor Diplomat Official
- Date of permit (less than 6 months)

Please present your GUEST COUPON when you make a purchase.

Your GUEST COUPON is valid for unlimited use for 7 days starting from the day of registration.

You can also receive a tax exemption after using the coupon.

GUEST COUPON may not be valid for items priced under 1,000 yen (excluding tax), sale items, lucky bags (fukubukuro), gift certificates, food items, or at restaurants and cafes.

It may also not be accepted at some other sales counters.









You can use your GUEST COUPON to get a 5% discount at the following stores.

•Hankyu Umeda Main Store, Kobe Hankyu, Hankyu Men's Osaka, Hankyu Men's Tokyo, Hakata Hankyu, Hanshin Umeda Main Store Your GUEST COUPON is valid for unlimited use for 7 days starting from the day of registration.

If the barcode disappears, you can get a new one at the coupon distribution counter.

- **The person named on the coupon must present it when you make a purchase. We may ask to present your passport when you use the coupon.
- **Please note that discounts do not apply to items under 1,000 yen (excluding tax), sale items, lucky bags (fukubukuro), gift certificates, food items, restaurants and cafes, and some specific items or brands. (For more details, please ask our in-store staff.)
- **Please note that this discount cannot be combined with other offers, such as point cards.
- *Please be aware that discounts cannot be applied after payment has already been completed.
- *You can still receive tax exemption when paying with Guest Coupon, UnionPay, WeChat Pay, or Alipay.

However, please note that tax exemption cannot be granted if the name on your passport does not match the name on your credit card. Also, please complete the tax exemption procedure at each store where you make a purchase.
